# November Forum: Stand with Families & Children in Our Community

For many years the LWV-RMA has advocated for adequate subsidies for quality day care for working families at or below 200% of the poverty level. Each year we have testified before the Monroe County Legislature, requesting more funding for Pre-K. This issue has been part of the League's National positions on advocating for the welfare of children.

For many low-income families, quality day care is unaffordable. The federal Child Care and Development Fund provides subsidies to many eligible families, but these families represent a small share of the families who are in need of such support. Day care for one child can cost up to \$12,000 a year; a second child in day care can cost a family up to \$24,000 a year. For a minimum-wage earner who earns \$16,640 a year, the cost of quality day care is prohibitive.

The League of Women Voters, in its National position, believes "that the first five years of a child's life are crucial in building the foundation for educational attainment and greatly impact success or failure in later life. Additionally the League believes quality, developmentally appropriate and voluntary early learning experiences should be available to all children, with federally funded opportunities going first to children of poverty and /or with special needs".

Research has shown that children who attend quality day care programs perform better in school than those who don't. Also, parents of children receiving subsidies can become gainfully employed, reducing the need for public assistance.

Thanks to generous support from the Beatrice Bibby Endowment of the LWV-RMA, the Center for Governmental Research has prepared a research report entitled "Child Care Subsidies in Monroe County – An Analysis of Need and Availability." Some of the issues CGR will address are the demand vs. the availability of child care subsidies, recent trends in the availability of subsidies, who are using subsidies in terms of age of children, family income level and other variables.

On November 13th at 7:00 PM the League and The Children's Agenda will sponsor a forum at the Asbury First United Methodist Church on East Avenue to present the findings of the Center for Governmental Research. Please join us to learn more about and discuss this important topic.

### The Beatrice Bibby Endowment

As you (hopefully) noted on the front page of this issue of The Voter, our November forum is described as the "Annual Beatrice Bibby Endowment Forum." For newer members who may be wondering what that means, we offer some background information.

Beatrice Bibby, a remarkable, active, community-minded League member, passed away in 2010 at the age of 101, having served as President of LWV-RMA and in numerous other leadership roles locally and at LWVNYS - as well as throughout the Rochester community. Ensuring the continuation of her lifetime commitment to philanthropy, Mrs. Bibby's endowment fund at the Center for Governmental Research (CGR) was established in 2010 and makes it possible for the League to continue to commission studies of issues important to this community and to present the findings at Public Forums.

Her legacy gift to CGR has enabled us to present forums on such topics as: the feasibility of government consolidation of the Town of Sweden and the Village of Brockport; Monroe County redistricting plans in 2010; Local Development Corporations (LDCs) (issued in 2007 and then updated in 2011); and creation of wetland maps for several towns in Monroe County.

This year our CGR study and resulting forum stem from our decades-long involvement as part of a coalition called the Early Childhood Development Initiative (ECDI) and our more recent affiliation with the Unite Rochester campaign. The issue of poverty in our community and the resulting discussions of ways to help our poorer families change their economic conditions has supported the conclusion that education plays a major role in our present condition. Over the past two years numerous meetings, study groups and committee work with LWV-RMA's various coalition partners led to our request that CGR research and report on childcare subsidies in Monroe County.

We trust that Bee (and the Bibby family) would be pleased with this forum.

# National Susan B. Anthony Museum & House announces 2015 luncheon speaker

The National Susan B. Anthony Museum & House is proud to announce that its keynote speaker for the 2015 Susan B. Anthony Birthday Luncheon is Lynn Sherr, Pulitzer Prize-winning journalist and biographer. The annual luncheon will be held Wednesday, February 11, 2015, at the Rochester Riverside Convention Center.

Her most recent work, **Sally Ride: America's First Woman in Space**, was released earlier this year and aptly illustrates the wonderful legacy of Susan B. Anthony. Sherr, who became close friends with Ride during her coverage of the space shuttle program, says Ride "acknowledged unequivocally that she wouldn't be at NASA without the women's movement and the social changes that had taken place". Ms. Sherr is also the author of **Failure Is Impossible: Susan B. Anthony in Her Own Words**, a 1996 biography of the great reformer.

Throughout her career in journalism, Ms. Sherr has reported on an array of women's issues, past and present, making her a perfect candidate to speak on the 2015 luncheon theme, *Thanks to Susan B., We Can Reach For the Stars!*, a celebration of the impact Susan B. Anthony's life and work has had on subsequent generations of women.

"Sally Ride made her way into space, and the history books, over thirty years ago. Yet, recent statistics show that women only make up 24% of those working in STEM (Science, Technology, Engineering and Mathematics) fields," says Deborah L. Hughes, President & CEO of the National Susan B. Anthony Museum & House and LWV-RMA member. "This luncheon will interest anyone fascinated by space and those advocates for advancing opportunities for women and girls in STEM."

The Susan B. Anthony Luncheon is held each year in mid-February to celebrate Susan B. Anthony's February 15th birthday, to honor contemporary women who continue her legacy, and to raise awareness of the educational and inspirational programs offered by the Museum.

### **Book Club Report**

Wow! I couldn't wait to get home and report on the best book discussion ever, which was led by Elaine Schmidt today!

The book was **A Mercy** by Toni Morrison, and five of us in Book Club found it filled with rich prose and symbolism. When we thought we had finished a thread of discussion, someone else would say, "Wait, what about this passage?"

Essentially it brings into vivid detail what it was like to live in 1690 in the cold northern colonies (we couldn't agree if it was Milton, MA or not).

The characters included several women, some of whom were slaves or indentured persons or burdened by religious dogma. A husband and wife gathered them all in as a family. Morrison focused on how each of the characters was flung into the world at a young age without any protection, and sought to find their voice, their identity, indeed, their very name. And yet, the impact of the various kinds of slavery revealed how fragile these relationships were.

All in all, this was a good read. If you haven't already read it, we hope you'll enjoy it soon.

# Education Update: A Visit With Daniel Delehanty of East High School

"What would Brown say?" This is the question that Daniel Delehanty, teacher and co-founder of the Ford Foundation-funded Teaching and Learning Institute (TLI) at East High School, asked our Education Study Group at its October 3rd meeting. He was referring to Oliver L. Brown, plaintiff in the Brown v. Board of Education Supreme Court decision. Is the segregation seen in the Rochester City School District (RCSD) defacto or is it created by law? It doesn't matter; the outcome is the same. Over 40% of most classrooms in RCSD are filled with students who are impoverished. This is one of the highest percentages in the United States and is, in Mr. Delehanty's opinion, unacceptable.

The author went on to suggest that, given the opportunity to attend suburban schools, many students would experience success. He used the term "social capital" to explain his prediction. Social capital is the concept that students learn through peers and make connections that will last for a lifetime. The peers in suburban districts have high expectations. They are planning on graduating and continuing their education. These same peers have greater opportunities to pursue the arts, athletics and intellectual activities not available to many RCSD students. He suggested that suburban districts allow 20% of their Kindergarten students to come from the City. When asked about the existing Urban-Suburban program, he said that it involves only 140 students out of the district's 30,000 students - a number he regards as inadequate.

"As a city resident, I can use the federal Post Office in Pittsford," Mr. Delehanty wrote. "I can use the canal and its bike path managed by the State of New York, visit the Pittsford branch of the Monroe County Library, drive the streets and walk the sidewalks maintained by the village. But if I dare to attempt to register my children for Pittsford schools, the best in the state, I will be turned away."

There is a passion in Mr. Delehanty's commitment to education. He believes that all students can benefit from integrated classrooms. "Stop trying to shore up the urban schools," he suggests, favoring instead a metropolitan county school system. He cites the success of the Raleigh, North Carolina education system as a model for reform. And he argues strongly that everyone benefits when we have an educated society.
