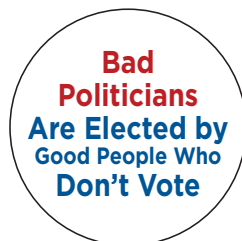

## Why Don't We Vote?

Good question, right?

A century ago, with the passage of the 19th Amendment almost assured, Susan B. Anthony told her followers that the right to vote was not the endgame – that the goal was to educate and to encourage the use of that vote. What would she think of the results of her efforts today?

According to the Monroe County Board of Elections Report for 2014, only 46.9% of the registered voters in Monroe County cast a ballot in what was a gubernatorial election year. While not great, this actually bested the 10 year average of 43.55%. If we discount the two presidential elections (turnout average 78%), our average for the period was 40.5%. Why is this? Is it a cultural thing or a reflection of our dissatisfaction – or simply fatigue?

A principal goal of our League since its inception has been, as Susan B. Anthony said, to promote and encourage voter engagement. Registration is not enough. How do we encourage our citizens to exercise their right to vote?

Please join us on Monday, September 21st, at 7:00 PM at Asbury First United Methodist Church for a discussion on that subject. First, what are the barriers to voting, and then, how do we move past them? Our moderator for the evening will be Timothy Kneeland, PhD, Professor and Chairperson of the History & Political Science Department and the Director of the Center of Public History at Nazareth College. Our distinguished panelists will be Andrea Cain, PhD, Vice President and Interim CEO at the Community Place of Greater Rochester, Inc. and George Moses, Executive Director of Northeast Area Development Inc.

The evening promises to be thought-provoking – and hopefully will inspire action in time for the upcoming elections.

## 50th Anniversary of the Voting Rights Act

August 6, 2015 was the 50th Anniversary of the Voting Rights Act. "A Journey of Justice," a week long walk with hundreds of people from Salem to Montgomery, Alabama, marked this most important federal legislation by celebrating the signing of the original legislation by President Lyndon Johnson 50 years ago, as well as the work that needs to be done by our country's citizens today in order to revitalize the Act.

When the Voting Rights Act was reauthorized in 1981 President Reagan said, "For this nation to remain true to its principles, we cannot allow any Americans' vote to be denied, deleted or defiled." After three years during which eleven states established election regulations that block people from voting, this statement is more true than ever.

The 2013 Supreme Court decision in Shelby vs Holder removed Section 5 of the Act, and the Voting Rights Amendment (VRA) has now been introduced in Congress (S1659 and HR 2867). LWVUS strongly supports these bills, as shown by the testimony of LWVUS President McNamara. All League members are urged to contact their representatives to urge them to vote in favor of updating the Voting Rights Act.

House of Representative Member Slaughter and both NY Senators Gillibrand and Schumer are co-sponsors. Please call and thank them for their support, asking that the bills be brought to the floors for a vote this fall.

For 95 years LWVUS has promoted free, fair and accessible elections. We continue to be leaders in all 50 states by advocating at state levels and national for voting processes that make voting more accessible. This year will see Leagues across the country protecting peoples' rights to vote. We'll continue to work on expanding the right to vote as all citizen voices need to be heard.

## The Future is Soon, or The NYS Constitutional Convention Ballot Question

What will you be doing on Tuesday, November 7, 2017? You will be looking at your election ballot with this question: "Shall there be a convention to revise the constitution and amend the same?" Yes, the every 20 years New York State Constitutional Convention question which not that long ago seemed way off in the future, will soon be here.

The last time the question appeared on the ballot was 1997 and the last time there was a Constitutional Convention was 1967. If the voters approve holding a Constitutional Convention, what is the process for convening a Constitutional Convention? How would delegates be chosen? What issues are likely to be discussed at the Convention? Can the Convention be limited in what it can propose?\* How are the proposed changes presented to the voters? What's the timetable? Of immediate concern, what changes in the process can be made prior to the November 7, 2017 vote?

LWV-RMA and TIAR (The Interfaith Alliance of Rochester) are co-sponsoring a forum "Nuts, Bolts and Monkey Wrenches of a NY State Constitutional Convention" to be held on October 19. More information will be in the October Voter.

\*That one is easy – the Convention cannot be limited and delegates can propose changes to any part of the Constitution (including discarding the entire Constitution and adopting a brand-new Constitution).

## Fiscal Report for 2014-15

For the fiscal year ending 6/30/15 we operated well within our approved budget.

The primary source of operating revenue was just under \$10,000 in dues from members, and our biggest expense was required membership payments to the NYS and the US leagues. These totaled \$5,365. We also received \$1,500 from the Monroe County Board of Elections for our work in the ballot process again this year. Our next largest expenses were \$2,400 each for state convention participation and for production of our newsletter, The Voter. Our change in operating funds was a net reduction of \$752 for the full year.

We are most grateful for a significant bequest of just under \$30,000 from The Gretchen Shafer Estate, which was deposited into our savings/investments accounts. Other contributions were received locally as well as directly to the Education Fund held at LWV-NYS. We thank all contributors for these additional gifts of support.

Thanks to the generosity of Bee Bibby, we were pleased to be able to fund an excellent research project by the Center for Governmental Research (CGR) in the amount of \$15,000. This analysis of child care subsidies in Monroe County has received great interest in the community, cited by the Democrat and Chronicle and several local not-for-profit groups in their advocacy work. A follow-up study was later conducted, again thanks to the Bibby Fund, in the amount of \$6,000.
