One of the most productive voter registration efforts took place this year – working collaboratively with our partner organizations, we registered well over 4,000 of Monroe County's 42,000 new voters!

The number of Facebook "friends," Twitter followers and website visitors steadily increases.

A new interactive database compiled by the Center for Governmental Research and funded by the Bee Bibby Endowment has proved to be a wonderful visual tool in targeting voter registration efforts and convincing would-be voters of the importance of voting.

Our new laptop has been a great asset in sharing our PowerPoint presentation in high schools and colleges – and we were able to use monies from the Education Fund, so our budget remains intact.

We continue to have a presence at local government meetings, making statements when issues arise which the League supports.

We've experienced some turnover in committee leadership and membership, but for the most part, new members have stepped up to prevent a lapse in activity. Every effort is important!

First Fridays are thriving! It's never been more fun to work together!

We welcomed 100 to 200 newly naturalized citizens every month, and registered many of them to vote.

Our board is committed to supporting League activities and committees – you've elected a hard-working, creative group!

Our annual *Who Represents You* brochure has been expanded to include judges as well as town officials – and the response has been very positive. We're grateful to the Rochester Area Community Foundation for its support.

Our network of partner organizations continues to grow and enhance our efforts in so many areas, from voter registration to sponsorship of forums to plans for upcoming women's suffrage anniversary celebrations.

Of course this list is not complete. And we do have challenges ahead, but the momentum built up in 2016 promises to make 2017 another proud year for the LWV-RMA.

Poverty Study Group Preparing Spring Forum

The Poverty Committee met with representatives from the Catholic Family Center (CFC) and The Community Place on September 30. We discussed CFC plans for implementing the contract they had received from Rochester Metropolitan Anti-Poverty Initiative (RMAPI) to address poverty reduction in the neighborhoods of Beechwood/Marketplace Heights/East Main Mustard and Atlantic Avenue (EMMA).

This Mentors for Success pilot will provide a person-centered approach connecting people to jobs and strengthening support systems that help them retain jobs. Mobility Mentoring and the Family Independence Initiative (FII) are two creative approaches for families to gain access to connections, choice and capital. The FII program has been used in Boston successfully and mentors from Boston will be advising the local effort.

The committee, which includes Larry Burnette, Sandra Frankel, Hasana Martin, and Chris Pryor met again on October 28 to discuss these programs and to prepare for a forum in the Spring. We welcome your joining us and bringing your ideas and questions.

A Banner Year for VOTE411.ORG ELECTION INFORMATION YOU NEED

Vote411 saw unprecedented traffic and visibility, including more than 4 million users nationwide (more than doubling our traffic from 2012). Nearly 25 million pageviews. VOTE411 was featured multiple times by The New York Times, and ran in a Spanish-language PSA on TV Azteca for months leading up to Election Day, reaching up to 39 million Hispanic individuals.

Locally, a greater percentage of candidates participated than ever before, fairly evenly divided between the two major parties. The Democrat and Chronicle referred readers to Vote411 several times during the campaign season. We don't have statistics on the number of users or pageviews for our races, but with the additional publicity, I think we can assume that our local traffic also increased.

The Attorney General's Office and You

WHAT WE LEARNED AT THE 11/14 FORUM

As head of the state's Department of Law, the Attorney General (AG) is both –

- The "People's Lawyer", guarding the legal rights of citizens, organizations, and resources;
- The State's chief legal officer, defending actions and proceedings for the State.

Over 650 Assistant Attorneys General and over 1,700 employees, including forensic accountants, legal assistants, scientists, investigators and others serve in satellite AG offices in many locations across our state. To explain what the AG office does and how it can help with our concerns and problems, two representatives of the Rochester AG office met with LWV-RMA members and others on November 14.

Ted O'Brien, Assistant Attorney General-In-Charge (AAGIC), provided an overview of services provided by the Attorney General statewide.

Ben Bruce, Assistant Attorney General, discussed some of the recent cases handled by the Rochester office. These included cases of snow plow contract fraud, disputes with credit card companies, toy safety, and charitable fund raising fraud.

The AG Office is organized into bureaus that apply statutory and common law powers to protect consumers and investors, charitable donors, the public health and environment, civil rights, and the rights of wage-earners and businesses across the State. The legal functions of the Department of Law are divided primarily into five major divisions: Appeals and Opinions, State Counsel, Criminal Justice, Economic Justice and Social Justice. The speakers noted that –

- Major cases leading to landmark decisions with national implications start with a single complaint.
- Major current areas of AG concern are identity theft involving senior citizens, senior health care, and tenant rights.

Consensus Meeting on NYS Legislative Procedures: A Cleaner Albany is Up to You!

Please join us for a presentation and discussion on updating the LWVNYS position on Legislative Procedures on Wednesday, December 7 at 4:00 P.M. at Brighton Town Hall (downstairs). The topics for the consensus are:

- Limits in outside income for state legislators
- Term lengths for state legislators
- Limits on length in leadership positions and committee chairs; should allowances be continued for these individuals?

To help you prepare for our discussion of these important facets of government ethics reform, we are providing some background information. We hope you will participate in strengthening the LWVNYS position so we can work effectively for ethics reform.

OUTSIDE INCOME:

- The base salary of a New York State legislator is \$79,500.
- In 2012, the average legislative income for currently sitting legislators, including stipends for leadership positions, was approximately \$89,500 for members of the Assembly, and approximately \$95,500 for members of the Senate.
- Legislators are reimbursed for costs associated with being a legislator: per diem when in Albany and transportation.
- The majority of our legislators declared no outside income in 2014.

TERM LENGTHS AND STAGGERED TERMS:

- Across the United States, there are wide varieties in term lengths, term limits (we will NOT be discussing term limits) and use of staggered elections.
- Representatives in the lower house of 44 states have a two-year term. Senators in 31 states have a four-year term and Senators in seven states have terms that are sometimes two years and sometimes four years.
- Staggered terms are generally thought of as a way to maintain institutional continuity.
- In the 38 states with either a four-year term or a 2-4-4 term, 27 states have staggered elections so that approximately half of state senate seats are up for re-election every two years.

TENURE FOR LEGISLATIVE LEADERSHIP:

- The N.Y. State Constitution gives each house of the legislature the power to make its own rules.

- In the current rules, the Senate has limited some of the Leadership titles to a maximum of 8 years. (This is new so no one has yet reached the limit)
- The Assembly Rules do not place any limitations on leadership positions or committee chairs.

LEADERSHIP ALLOWANCES (COMMONLY KNOWN AS LULUS):

- The Legislative Law identifies 24 Senate officers, 34 Assembly officers, members of each house "Serving in Special Capacity", committee Chairs and Ranking Minority members of each committee, each of whom receives an "allowance," ranging from \$9,000 to \$41,500.

Only League members can participate in the consensus discussion.

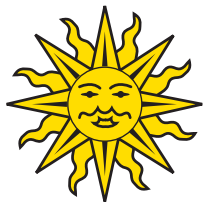

Once again supporters of increased funding for Child care spoke to the Legislature. Although the proposed budget for 2017 includes an increase of \$100,000 for child care, the supporters were asking for \$1 million more. They said the proposed increase would cover only 16 additional children and believe it is possible to do more.

County Executive Cheryl Dinolfo cited the dissolving of county LDCs as a source of savings that helped her to keep the property tax rate unchanged at \$8.99 per thousand.

Once again the legislators heard pleas for increased services for Special Education services and for support of veteran-run small business owners.

Voting Rights News

Residents of what jurisdiction on this map have no voting representation in Congress?

If you said, "Washington, D.C.," you were right! In 1961, the Twenty-third Amendment to the U.S. Constitution gave the District three electoral votes in the election of the President and Vice President of the United States. However, the 600,000 residents of Washington still lack voting representation in Congress and real home rule.

In 1978, Congress passed a constitutional amendment to give D.C. full voting representation, but it was not ratified by the states. Frustration by the lack of progress on full voting representation and by recent actions by Congress to block decisions by D.C. voters led to an advisory referendum in November supporting D.C. statehood. Washington, D.C. would be split into a new state for its residents (New Columbia) and a smaller federal district for government buildings and monuments. The referendum was approved by 79% of the voters. The petition will now be delivered to Congress.

The LWVEF and the LWV of the District of Columbia are conducting a webinar "Fix the Hole in Our Democracy" on Thursday, December 8 at 7pm. Register for the Webinar now and hear how you and our League can educate our community on the need for full representation and statehood for DC. A relevant recollection: I attended the LWVUS Convention in Washington around 1990. I went into the Ladies Room where an elderly woman missing her front teeth was mopping the floor. She asked if I was attending the League of Women Voters meeting. When I said that I was, she straightened up and said, "I'm a League member! I joined the League because it supports voting rights for Washington."

It's Over...But It's Never Over

The Board of Elections has confirmed that our voter registration count came in at nearly 4,000 for this year. Our success can be attributed to two factors – our dedicated group of volunteers and the community groups who joined in our efforts.

As part of "MAKING DEMOCRACY WORK FOR ALL", we strived to reach a diverse audience, participating for the first time in the **PRIDE Fest**, **ROC The VOTE** and the **PROJECT HOMELESS CONNECT** events while continuing our role at the Naturalization Ceremonies. We were also able to offer our services at the Rochester Psychiatric Center, Rochester Rehabilitation Center, Rochester Recovery Network, Lifetime Assistance and Monroe Developmental. Working with the Rochester Voter Alliance, our volunteers were particularly active in the Anthony Jordan and Trillium Community Health Centers. We also continued to work very closely with FingerLakes Donor Recovery, participating in a wide range of community and neighborhood events, including two Red Cross blood drives and several TIPS and farm market spots.

Our volunteers made multiple presentations of our Civics power point at the School Without Walls, School of the Arts, World of Inquiry, Northeast Prep, East High, Aquinas and Edison Tech, and expanded their efforts to include a LifeSpan audience. They continued their work on our local college campuses, registering students, faculty and staff at Monroe Community College, Rochester Institute of Technology, SUNY Brockport, the University of Rochester, Eastman School of Music, Nazareth and SUNY Geneseo.

BUT the job is not done. As our recent elections have shown us, registration is only part of the job. We must continue to focus on encouraging voter participation. This can only be accomplished by working with our community partners, educating the public, and increasing our advocacy efforts.
