May GO-SEE Tour! Visiting High Acres Landfill

May 3, 2012 marks our 13th Annual GO-SEE Tour (rain or shine)!

Members, visitors and guests welcome.

Meet at Applebee's Restaurant (northwest corner of strip mall Rt. 250/Rt. 31) in Perinton.

Board the school bus which will take us to the site where we will visit the landfill and learn about all the changes and improvements that have occurred in landfills over the years. The bus will return us to Applebee's for lunch (you pay).

Have you ever stopped to wonder about where your garbage ends up after you throw it away? High Acres is not just a place where trash is buried and never thought of again. This facility, as well as the Mill Seat Landfill in Bergen, has a renewable energy plant where methane gas is collected and converted into energy that is sold back to the national grid. Landfills must always deal with the issue of getting rid of methane and while most places burn it away, Waste Management has tapped into the concept of making it useful as electricity. Currently, enough energy is collected to power 9,000 homes. High Acres is in the process of applying for a permit to expand the operation so that more energy can be created.

Waste Management works hard to incorporate natural wildlife habitats into its facilities. As scavengers, seagulls are naturally attracted to landfills and often become a nuisance. But, High Acres has introduced falcons, which are birds of prey and, in turn, help keep the seagulls at bay (no pun intended). The LWV/RMA has a history of advocating for safe landfills and in the past testified several times before the county legislature regarding proposed landfill sites.

Directions:

From the north: Route 250 south, through Fairport and almost to Route 31; turn right into strip mall at the traffic light (just before intersection with Route 31). School bus and Applebee's will be apparent.

From the north and west: Route 490 east and exit to route 31 east; turn left at Route 250 and left again at next traffic light into strip mall and Applebee's.

Sandra Doorley

Sandra Doorley is the District Attorney for Monroe County, New York and the first female to hold that office. Doorley took office in January 2012, succeeding Michael Green for whom she served as First Assistant District Attorney.

For the last twenty years, Sandra Doorley has successfully prosecuted thousands of criminal cases. In her career as an Assistant District Attorney, Doorley prosecuted many high profile cases. Recently, she was appointed to lead the Appeals Division within the DA's office.

Doorley has become a known leader in the prosecution of cold cases using DNA evidence and has been successful in obtaining indictments and convictions on many cold cases, including the 1976 murder of a young girl in Rochester and the conviction of a serial offender for 1995 and 1996 murders involving sexual assault.

In January 2011, Sandra was honored by the New York State District Attorney's Association with the Robert M. Morgenthau Award in recognition for her professional accomplishments, honesty, integrity and commitment to the fair and ethical administration of justice.

Doorley obtained a Bachelor's Degree from the University at Albany and received her law degree from Syracuse University.

Voter Services Annual Report 2012

The League has been represented at the bi-monthly Naturalization ceremonies by Sheila Abeling, Marcia Eisenberg, Kathy Farrar, Beth Feldman, Barb Hendry, Joan Rosenthal, Mimi Wilson, and Lois Winterkorn. League members explain to new citizens what registering to vote means and then helps them complete voter registration forms. At the ceremonies, we have distributed more than 1,500 registration forms this calendar year.

We published our brochure **WHO REPRESENTS YOU** 2012. Five thousand brochures were printed and are being distributed to various community organizations, including libraries and the Board of Elections. The League was awarded a grant for \$5,000 from the Rochester Area Community Foundation to cover publishing **WHO REPRESENTS YOU** from 2008 to 2012.

League volunteers opened absentee ballots for the Board of Elections at the September Primary, November General Election and the April Presidential Primary. We have wonderful, reliable volunteers in the League!

Voter registration drives were successful. We discussed the process of voting and helped to register those qualified to vote at several events and places: General Hospital's "Spring into Safety", St. John Missionary Baptist Church's Block Fair, Constitution Day at Nazareth College, "Books Sandwiched In" at the Rundel Library, Brighton High School's "Wellness Fair", Clothesline Art Show at the Memorial Art Gallery, Greece Ridge Mall, and Brighton Highlands Home.

Our Fair Election Practices Campaign encourages all candidates for public office to run positive, issues-oriented campaigns. Some candidates feel that negative ads are effective. The League believes that positive campaigns that address important issues are winning campaigns. This year the Committee monitored complaints and held ten hearings. The 2011 Committee members were: Jim Morris (Chairperson), Ralph Esposito, Lois Giess, Channing Philbrick, and Kay Wallace. Alternates were John Curran, Tom Frey, Tracy Logel, Jim Peters, Sue Roberts, and Jim Turner.

The League made itself available to speak in the community about the importance of voting. We met with students from elementary to high school levels. Also, we visited and spoke at area senior citizen facilities and refreshed their knowledge of the importance of voting.

This year, the League sent Teresa Leone, a junior at School Without Walls High School, to STUDENTS INSIDE ALBANY 2012.

The Rochester Voters Alliance (RVA) is a coalition of not-for-profit, non-partisan, interfaith, civil rights, and community-based organizations devoted to providing education to Monroe County citizens on the importance of informed voting, register voters, and remind voters to go to the polls on Election Day.

The League has continued its liaison with the Rochester Voter Alliance. We will work with different community organizations to help accomplish the above goals in this 2012 Election year.

The League had the wonderful opportunity to work with Election Fellows at the college level. The Election Fellows Program, funded by the U.S. Election Assistance Commission (EAC), was created after the passage of the Help America Vote Act College Program in 2002. The program selects two Election Fellows from each participating college to recruit students to work the polls on Election Day in November. Area colleges have been involved in this endeavor. Our League has worked with the students for the past two years. This year we worked with Nazareth College students and were able to engage several students in the excitement of voting and becoming recruits. The Board of Elections (BOE) Commissioners are thrilled with the Fellows. They consider the participation of the Fellows as "a win-win for both the students and the BOE."

Voter Services' goals for the coming year include:

- increase visibility of the League in the community
- increase the number of voter registrations
- increase our Voter Services volunteers
- increase our volunteer activities with the Board of Elections
- continue to educate citizens about the importance of voting and participating in our democracy.

Annual Report, Action

As Director for Action, I've been meeting with local state senators and assemblymen to lobby for the state league legislative agenda. This year we are focusing on 4 issues:

Campaign Finance Reform. The League is lobbying for lower donation limits for individuals and corporations, fuller disclosure rules and public financing of campaigns.

Election Reform. We are lobbying for some relatively technical changes to rules about paper ballots, and for a constitutional amendment to permit same-day registration.

Court Simplification. New York's court system is overly complex and inefficient. Streamlining the eleven layers of trial courts could save money and make justice more accessible.

Moratorium on Hydro-Fracking. The League believes that there is no way at present that the DEC could regulate hydro-fracking in a way that protects the environment and public health, and permits should not be issued.

Students Inside Albany

Junior, Teresa Leone of School Without Walls represented our League in Albany. She was among the 54 students who participated March 25-28 in LWVNY State Education Fund program called STUDENTS INSIDE ALBANY.

"This interactive conference," explained the State League, "brings together male and female high school students from across the state to learn about New York State government and the process by which citizens can participate in the policy-making arena." The conference included:

- seminar on the basics of state government;
- tips on successful lobbying by the NYS League's legislative expert in Albany, Barbara Bartoletti;
- lobbying role-playing session with upstate Assemblywoman Teresa Sayward;
- primer by both a Republican and a Democratic assemblyman on how to run for office;
- workshop by the executive director of the Alliance for Quality Education and a New York State United Teachers (NYSUT) official on lobbying and organizing a political campaign;
- seminar on the Freedom of Information Law (FOIL) and the Open Meetings law by Robert Freeman, executive director of the NYS Committee on Open Government;
- discussion on the role of the media, by both the producer and the host of the YNN Albany political news television program "Capitol Tonight."

As part of the program, students also toured the State Capitol building, observed the State Senate

and Assembly in action, and shadowed both their State Senator and Assembly person. Teresa shadowed Senator Joseph Robach and Assemblyman Harry Bronson. When Teresa was first asked about her experience after returning from Albany, she said, "I wish that it had been longer." She really enjoyed the entire experience and thanks the League for the opportunity.
