# The Need for Ad Watching in 2012


From December through early August, 10 third-party groups spent just over \$108 million in ad dollars on the presidential contest, over half (51%) of it on 35 ads containing deceptive or misleading claims.

From December 1, 2011, through June 1, 2012, 85% of the dollars spent on presidential ads by the four top-spending third-party groups known as 501(c)(4)s was spent on ads containing at least one claim ruled deceptive by fact-checkers at FactCheck.org, Politi-Fact.com, the Fact Checker at the Washington Post or the Associated Press.

The Annenberg Public Policy Center of the University of Pennsylvania has funded www.factcheck.org whose mission is to "monitor the factual accuracy of what is said by major U.S. political players in the form of TV ads, debates, speeches, interviews and news releases. Our goal is to apply the best practices of both journalism and scholarship, and to increase public knowledge and understanding."

A sister site, www.flackcheck.org, was recently established to examine the lighter side of spin. Its mission is to use "parody and humor to debunk false political advertising, poke fun at extreme language, and hold the media accountable for their reporting on political campaigns."

# Who Loses with Current Campaign Finance Laws?

It is sad to say that we, the people, lose!!

It is not well known outside Albany that the existing system of reporting campaign contributions is routinely ignored. Many people, including the League of Women Voters, believe that enactment of strong campaign finance laws which are adequately enforced constitute the pathway to solving major election problems by increasing voter participation, enabling candidates to compete more equitably for public office, and lessening the impact of special interests on governmental processes.

When most of the money spent on politics comes from a small number of people who can afford to contribute large amounts of money, the result is unequal political power. The New York Public Interest Research Group (NYPIRG) recently found that over one-third of the money that state candidates and political parties raised last year came from just 127 ultra-wealthy donors.

On October 11 we will present an educational program that LWVNY has developed to inform us of:

- the current state of campaign finance laws and their enforcement, weaknesses and limitations
- other states' laws and their enforcement
- alternatives for consideration in New York State.

This will prepare us to evaluate the proposed legislation expected soon from the governor's office.

# VOTER PROTECTION FOR DOMESTIC VIOLENCE VICTIMS

In 2010 New York State changed several laws to provide voting protection to domestic violence victims. Voting is a right that sometimes has been denied to victims of domestic violence. Balancing their need for safety against their desire to participate in the voting process, victims were forced to choose between registering to vote and forgoing voting in order to maintain their personal safety and the confidentiality of their address.

Polling places are a matter of public record and, by law, are easily accessible. They can become ideal places for victims to be stalked or confronted by their abusive current or former partners.

New York State Laws of 1996, Chapter 702 allowed domestic violence victims or members of their family to vote at the Board of Elections with special paper ballots. However, that law did not define who is a "victim of domestic violence" or who is a "member of their family." New York State Laws of 2010, Chapter 38 amended the law by expanding the requirement that a victim must have left the original residence due to threats of physical harm, to now include threats of emotional harm not just to themselves but also to members of the "same family or household." The 2010 amendment defined "family or household members" as:

- Persons related by consanguinity or affinity.
- Persons legally married to one another.
- Persons formerly married to one another regardless of whether they still reside in the same household.
- Persons who have a child in common regardless of whether such persons are married or have lived together at any time.
- Persons who are not related by consanguinity or affinity and who are or have been in an intimate relationship regardless of whether such persons have lived together at any time.

While voter registration access is sometimes limited to political parties or candidates, journalists and academia, a study conducted by The California Voter Foundation (from "Voter Privacy in the Digital Age: A Report by the California Voter Foundation" by Kim Alexander and Keith Mills. May 2004) indicates that 22 states have unrestricted access to voter records. Currently New York State allows for voter registration records to be made public to ANYONE who submits a request in writing and cites the correct law reference. This access to registration records unintentionally places domestic violence victims in a position

of vulnerability and risk, rendering their address of residence easily available to their abuser. For victims seeking to rebuild their lives, the threat of having such information become public is, quite simply, unacceptable, and they will choose the absence of participation in the voting process over the risk of harm to themselves and their families. New York State Laws of 2010, Chapter 73 created Election Law §5-508 which allows victims of domestic violence to have their election records kept separate from the publicly available election information.

In order to have their information kept confidential, a domestic violence victim must apply to the Supreme Court in the county where they reside for a court order requiring the County Board of Elections to keep their registration information confidential. They must have been a victim of a family offense or violent felony which resulted in emotional or physical injury, or the substantial risk of emotional or physical harm to themselves or their child. They must also be a "member of the same family or household" as defined above.

This is Domestic Violence Awareness Month. We encourage individuals to exercise their right to vote. It is important to remember these important protections so that everyone can vote AND remain safe.
