When we joined the Membership and Leadership Development (MLD) program led by national League coaches, we were told such visibility does attract new members. ## Untold Truths: Immigration & You

What happens in a society that allows its government to discriminate against an entire class of its members? Martin Luther King, Jr. gave us the answer from the Birmingham Jail in 1963: "Injustice anywhere is a threat to justice everywhere."

And what happens when that same government is allowed to codify derogatory language against that same population? We learned our lesson on the balcony of the Lorraine Motel not long after that Birmingham letter.

I once stood at that place and felt the earth move under my feet. Everyday I see firsthand the result of discriminatory, anti-Constitutional law against my neighbors who happen to be farmworkers, attempting to find their American Dream, away from the extreme poverty and sometimes danger and violence of their homelands. Everyday I see the results of codified pejorative language in our laws: Illegal aliens. Aggravated felons. Children of undocumented farmworkers living in depression and fear. Fathers crying because their children cannot engage in community activities. Mothers cowering in their cars on their way to church, afraid their families will be destroyed by Immigration & Naturalization Service (INS) agents looking for bonus Home Depot cards or trying to fill their quotas of meaningless arrests.

Today the League of Women Voters supports "Embracing Race" in Rochester. Come engage in conversation on April 22 as our League leads the community in a look at the issues of our farmworkers and their families. Andrea Callan, a Constitutional and civil rights lawyer for the New York Civil Liberties Union; Reverend Richard Witt, Director of the Rural and Migrant Ministry; and Reverend Chava Redonnet, Chaplain at St. Joseph's House of Hospitality, a small migrant community, will discuss the realities of migrant life today with a vision of where we are heading with this most important human rights issue tomorrow.

## Hydrofracking Legislation Update from LWVNY

LWVNY has issued a Memorandum of Support for S.0674/A.1046 which "relates to the uniform treatment of waste from the exploration, development, extraction, or production of crude oil or natural gas," requiring hazardous waste produced from oil and natural gas activities to be subject to the requirements for treatment of hazardous waste."

Current Department of Environmental Conservation rules exempt "drilling fluids" from regulation as hazardous waste. This legislation would ensure that when such waste "meets the definition of hazardous waste, that it be treated in a manner consistent with other hazardous wastes."

LWVNY strongly urges all League members to support S.0674/A.1046.



## Milestones

We are sad to report the death of long-time league member, Sally Chamberlin. Sally was a native of Chappaqua, NY who went on to Wellesley College. She married, had two sons and a daughter, and was widowed at an early age. She volunteered at many organizations, including The Greater Rochester Coalition for Immigration Justice, The Raging Grannies, The Rochester Voters Alliance (on which she served as a co-chair) and The Interfaith Alliance of Rochester (on which she served as a former president). She had also been involved in Moving Beyond Racism and served on the board of One World Goods and the Pittsford Village Planning and Zoning Boards. She joined the League when we undertook our national study on immigration in 2008. She served as our liaison to the GRCIJ, and was instrumental in bringing the two groups together to plan our April 22 forum.

Sally had been recruited recently to help plan the League's April program on immigration. A memorial service will be held at 1PM on April 6 at the First Unitarian Church.

## 2013 Budget

Just one year ago we met to discuss fiscal year 2013, a year of unforeseen success. Our accomplishments this year can be attributed to the dedication of our board, active members and the community we call home. I want to give special thanks to our Budget Committee – Rita Garretson, John Schmitt, Georgia DeGregorio (ex-officio), Tom Ferrarese and Ellen DeGregorio – for their insights, diligence, and leadership.

Today we have increased our cash reserves and our development funds, are 131 members strong and continue to invest in our community through our educational and programmatic activities. I'm proud to report that our projected income has increased 70.29% over last year.

Revenue increases are a result of increased development efforts, funds donated by B. Bibby at the Center for Governmental Research (CGR), and increased receipts from membership dues. I would be remiss if I failed to mention our membership is up over 10% this year, illustrating our impact and increased public awareness. Because the funds that come from CGR are restricted we have to spend the monies on an approved project.

We have been good stewards and have committed to a responsible amount of expenses. Sending 3 active members to the League of Women Voters National Convention will prove to be a good investment. Upon return from a convention of this magnitude our delegates will bring home invaluable knowledge, ideas and experiences to make our local League the best it can be.

I have included last year's budget on the following page, along with projected numbers for comparison reasons. Our budget committee hopes you find this format informative and understandable.

## What Happens at Naturalization Ceremonies?

On the afternoon of February 14, 2013 I decided to attend a naturalization ceremony and see what all the excitement is about. Here is what I found:

They came from all over the world: People's Republic of China, Latvia, Ukraine, Democratic Republic of the Congo, South Korea, Colombia, Philippines, Sri Lanka, Vietnam, Trinidad and Tobago, Somalia, Pakistan, Australia, Cuba, India, Singapore, Romania, Jamaica, Qatar, Ethiopia, Poland, Bangladesh, Dominican Republic, Russia and Nigeria!

We all recited the Pledge of Allegiance led by a 10 year- old and her father from Ukraine. There were 48 new citizens in the morning session as well. In fact, an average of 100 new citizens are welcomed each month according to Sheila Abeling, our League director, who makes sure that League members attend the ceremonies and give the citizens a warm welcome and a pamphlet, "First Vote", along with a voter registration form.

Whenever you feel pessimistic about the future of our country, I urge you to come to a naturalization ceremony. I volunteered to help our representative on February 14th. I'll never forget the smiles and joy expressed by these happy people. And I simply had to share my delight with you. Especially moving was the young woman who "waited 12 years to get to this day" and came on crutches because of an accident damaging her knee. The tears in her eyes touched us all.

## Advocacy

The Governor of the State of New York, after two years of talking about changing the way elections are funded in our state, has begun speaking about a program bill he plans to introduce to the New York Senate and Assembly in April. Governor Andrew Cuomo is indicating that the bill will have a proposed system of public and private monies for candidates to use during campaigns. LWVNY supports a matching of public and private funds for this purpose.

LWVNY favors a comprehensive bill which has not only a public funding component, but also lowers the limits on liability corporations, limits money for political party expenses and establishes an independent enforcement board. The present influence of money in campaigns, lax laws governing spending and the amount of time that elected officials spend raising this money are the reasons citizens want these changes.

When the bill is introduced, LWV/RMA will send an email alert. Please call your New York State Senator and Assembly Member stating your strong support for fair elections with limits on spending and lower limits on donations. We need fair elections where the number of small donors increases and the number of people able to run for office increases.
