## **Advocacy Summary for Legislative Sessions**

At the state level the Women's Equality Agenda was passed by the NYS Assembly on June 20, with all ten provisions proposed by the Governor. The NYS Senate, on the other hand, voted on nine separate bills that had different language, so there was no bill (or bills) for the Governor to sign. The LWV-RMA is supporting a special Assembly session to vote on the Senate bills, but this is not likely to happen. We'll be lobbying for the WEA in 2014 – look for information and join us. Your help will be needed.

At the national level LWVUS has been a strong supporter of the immigration bill that passed in the US Senate in June. We are lobbying our Congressional members to vote on a bill this session.

The LWV's major effort this fall will be to address the US Supreme Court decision on the 1965 Voting Rights Act. As you read in the June/July Voter, we will be putting all our resources at the national, state and local levels toward ensuring that all citizens have easy access to the polls in November.

The October Voter will have a summary of NYS Constitutional Amendments that we'll be voting on this November.

Note that our LWVNY Legislative Director, Barbara Bartoletti, has been asked to be a Special Advisor to the Moreland Commission to investigate public corruption.

#### **GET OUT THE VOTE**

In the last mayoral election (in 2011), less than 26,000 votes were cast, while the number of registered voters in the city exceeds 100,000. To encourage registered voters to actually vote, we are inviting them to sign a pledge to vote and offering them a reminder. We will email and text reminders of election times, along with links to our Vote 411 online voters' guide.







## Voter Registration on the 4th of July

Thirty-two new citizens from twenty-three countries attended the July 4th Naturalization Ceremony at the Genesee Country Museum. LWV-RMA members Beth Feldman, Kathryn Saunders and Katherine Smith helped register the new citizens for voting in November.

As Judge Frank Geraci told the candidates "Being an American is not a spectator sport. In this country you are the government." The 32 new citizens were excited to be registering and looking forward to voting for the first time in their new country in November 2013.

LWVRMA members register new citizens twice a month at naturalization ceremonies here in Rochester. Sheila Abeling coordinates these events with Immigration Services out of Buffalo and volunteers from LWV-RMA. We register nearly a thousand new citizens each year!

Before the formal meeting, speakers at the Legislature addressed the plans to have the Monroe County Fair at Northampton Park. Of concern to the League is that some said they had not been properly informed about the plans. Many were concerned about sanitation, traffic and stress on wildlife in the Park. The vote to pass the resolution was approved along party lines with the Republican majority voting in favor and the Democratic minority voting against the proposal.
