## Facebook

I wanted to write this article to introduce a new venture we have undertaken and why I feel it is necessary to utilize it in order to promote our voice. We recently set up a Facebook page for LWV/RMA. Let me give you a little background on Facebook. First, Facebook is a social networking service and website launched in February 2004, operated and privately owned by Facebook, Inc. Users may create a personal profile, add other users as friends, and exchange messages. Facebook users must register before using the site. Additionally (this is where we fit), users may join common-interest user groups, organized by workplace, school or college, or other activities.

## VOTE ROCHESTER is Starting to Roll

Our goal is to bring Monroe County from near the bottom in rates of voter registration to the top. Specifically, we'd like to increase the number of registered voters by 57,000 before the 2012 general election.

Unregistered voters are everywhere in Monroe County (about 1/3 of adult citizens are unregistered), but they all have many friends who are registered. If we can get enough voters asking their friends to register and vote, we could reach most of them.

We're starting to look for all kinds of ways to make that happen. Our first thought is partner organizations. What if many organizations in Monroe County went down their membership rolls and determined which of their members are not yet registered voters? This might make a good project for a youth group. What about Girl Scout troops? Chamber of Commerce groups? Rotary clubs? Neighborhood associations?

Another conversation we're having is about individuals or groups setting goals and sharing a wish that inspires them. Maybe, an organization would like to set a goal of registering a certain number of new voters and celebrate when they achieve it with a big organizational barbecue. Goals could lead to wonderful things in Rochester, as people recognize each other's contributions and make new connections.

Our website is live: [www.VoteRochester.org](http://www.VoteRochester.org). Anyone can join by creating an account. Once you've done that, you can keep track of voters you've registered. You can also look up your friends to see if they're registered. You can also share a picture or a story about voting, to help inspire others. You can also "like" us on Facebook or sign up for our electronic newsletter.

Our team has made contact with the Social Studies department in the Rochester City School District. We'll be visiting each Participation in Government (PIG) classroom to talk about the importance of voting and invite them to join up. We need volunteers to make these classroom visits, so if you'd like to help, please let us know. We'd love to do the same thing in other school districts. If you could make a connection to help that happen, please contact us. We'll meet such requests to the extent we can find the volunteer energy to do so. We're using a curriculum that's been developed - you don't have to be an expert teacher to do these visits!

## Constitution Day Speaker

Daan Braveman, the ninth president of Nazareth College, is a Rochester, NY, native. Braveman graduated from Brighton High School and the University of Rochester. He obtained his law degree from the University of Pennsylvania and was a law clerk to Justice Samuel J. Roberts of the Pennsylvania Supreme Court. He worked as an attorney for the Greater Upstate Law Project, located in Rochester. While at the Project he was engaged in civil rights litigation throughout New York State. Braveman joined Syracuse University College of Law in 1977 and served as Dean from 1994 - 2002. During his tenure, he taught courses in civil procedure, civil rights, constitutional law, federal courts, and federal Indian law, and was one of the founders and directors of the Public Interest Law Firm at the College. He has published many articles and books on constitutional law, civil rights, legal education, and federal Indian law. In 2005, Braveman was inaugurated as the President of Nazareth College.

## League of Women Voters Launches Clean Air Promise Campaign

Washington, DC – The League of Women Voters today launched a months-long campaign, including a significant national advertising effort, seeking to renew America's promise to protect clean air and public health embodied in the highly successful and popular Clean Air Act.

"Americans from all walks of life will be asked to make the 'Clean Air Promise,'" said Elisabeth MacNamara, president of the National League of Women Voters.

"We are deeply concerned about attacks on EPA and health protections. Any action to block the EPA from updating Clean Air Act protections, or any delay on behalf of the Administration to avoid implementing new clean air and industrial pollution requirements, is an attack on the health of our children and families, plain and simple," she said.

The Clean Air Promise Campaign will call on citizens, elected officials and community leaders around the country to join in making this simple promise to protect the health of our children and families:

- I promise to protect America's children and families from dangerous air pollution.
- Because toxics and pollutants such as mercury, smog, carbon, and soot, cause thousands of hospital visits, asthma attacks, and even deaths.
- I will support clean air policies and other protections that scientists and public health experts have recommended to the EPA to safeguard our air quality.

The League will ask its members to make the promise to protect clean air and will actively work to engage the public and our leaders to make the promise as well. Other clean air advocacy groups are expected to join the campaign in the coming days and weeks.

## October Forum Speaker

A specialist in American legal history, race and the law, Paul Finkelman is the author of more than 100 scholarly articles and more than twenty books. He is an expert in areas such as the law of slavery, constitutional law, and legal issues surrounding baseball. He was a Fellow in Law and the Humanities at Harvard Law School and received his Ph.D. and M.A. from the University of Chicago. His scholarship on religious monuments in public space was cited by the U.S. Supreme Court in *Van Orden v. Perry* (2005). His work on legal history and constitutional law has been cited by numerous courts and in many appellate briefs.

## LWV Membership and Leadership Development (MLD) Initiative

LWV/RMA was recently selected to participate in a leadership development training program conducted by the League of Women Voters of the United States (LWVUS). ## Observer Corps

**County Legislature** 7/12/11. The meeting was conducted in an orderly and efficient manner. Several items were passed with little or no discussion before the public. The evening's discussion centered on MCC's operating budget for 2011-2012. Rep. Paul Haney presented 2 amendments to decrease certain expenditures; both were defeated 13-15 along party lines.

A member of the public, Jeff Goldblatt, addressed the legislature regarding an issue of hazardous waste. He called for a new flyer to be developed to inform citizens on how to properly dispose of used syringes and other hazardous waste. This is an issue the LWV follows.

**Irondequoit Town Council Workshop.** Under 5 people attended this meeting which is open to the public. The meeting was orderly and discussion could be heard. Sea Breeze Water Authority was discussed.

Due to a negative cash flow the possibility of merging with Monroe County Water Authority was entertained. Further investigation is planned. Sea Breeze Water is an LDC, another of LWV's focus of interest.

**Irondequoit Town Council** 7/19/11. Orderly meeting with cable TV coverage. There appeared to be an intermittent problem with the microphone.

The issue of a change in zoning from R-1 to R-7 along Titus Ave. to allow the Legacy Senior Housing project continues. There will be a second public hearing after review by the Planning Board. Question of whether appropriate venue for project review should be Zoning Board.

Proposal for a cell tower near St. Paul Fire House was again tabled.

**Greece Town Board,** Preliminary Agenda, 7/13/11. Under 5 people were present for this public meeting. The meeting was orderly and audible. No issues presented that were LWV issues.

**Rochester City Council** 7/19/11. Over 20 attended this meeting. It is noted that there was no agenda available prior to the meeting which was orderly and audible. Standing room only during public comment portion of the meeting.

There was little discussion on the proposals. No LWV issues were brought up.

A life-long Milwaukee resident, Senator Lena Taylor is serving her second term in the Wisconsin State Senate, representing the 4th Senate District, including northern portions of the City of Milwaukee. Taylor was elected to the Wisconsin State Assembly in a special election in April 2003 and was subsequently elected to the Wisconsin State Senate in 2004.

In early 2011, the Senator took a principled and dramatic stand against Governor Scott Walker's goal of ending collective bargaining as part of the "Wisconsin 14"—the fourteen Democratic Senators who left the state in order to prevent the passing of the "Budget Repair Bill" that would strip away the right of workers and end democracy in the public sector workplace. Taylor and her colleagues were and are revered by many for their stand in support of workers' rights in Wisconsin. The National Education Association awarded Taylor and the rest of the Wisconsin 14 individually their 2011 Friend of Education Award, the first time ever the award was granted to a collective group's action. # The Latest on Fracking

This weeks' newspapers contained articles that three of NY southeastern counties, Broome, Tioga and Chemung are targeted for drilling. This is due to four basic parameters (depth, thickness, core pressure and richness of natural gas) found in the Marcellus shale 3-4,000 ft below the surface in this area. The Binghamton area is likely to be targeted first.

Fifty eight applications for fracking have been filed with the NYS Department of Conservation. The Department received more than 13,000 public comments on the first Draft Supplemental Generic Environmental Impact Statement (SGEIS) issued in September 2009. The Draft SGEIS addresses permit conditions required for gas drilling in Marcellus Shale.

In response to issues raised, DEC has prepared a Preliminary Revised Draft SGEIS. As of July 1, an Executive Summary of the document is available for public review. To help those interested in understanding the issues involving horizontal drilling and high-volume hydraulic fracturing, several fact sheets are also available. Comments are being accepted. See [www.dec.ny.gov](http://www.dec.ny.gov).

Several flaws have already been identified by environmental groups regarding the Preliminary Revised Draft SGEIS.

It doesn't ban any chemicals—even those known to be toxic and carcinogenic. It fails to classify drilling waste as hazardous—even if it is hazardous under the law.

It would allow sewage plants to treat drilling waste—even though New York's capacity and ability to treat drilling waste is questionable.

It would inadequately protect drinking water supplies.

It would restrict some areas of the state to drilling—but many restrictions would expire, and some only call for individual review rather than complete prohibition.

It does not analyze public health impacts, even though there is growing evidence of negative health impacts related to gas extraction in other states.

It would allow fracking permits to be issued before the recommendations are complete and finalized in hard and fast regulations.

It breaks up environmental impact reviews by different agencies and processes, which would result in disjointed reviews. Governor Cuomo must require state agencies to coordinate their efforts.

It would inadequately protect—or completely fail to protect—aging drinking water infrastructure in New York City, Syracuse, and other areas.

It does not provide for adequate staff or resources to properly oversee fracking.

The League supports national regulation of hydrofracking and a moratorium on hydrofracking in New York State at least until the full life cycle and cumulative environmental impact of this method of gas extraction has been fully considered by the Environmental Protection Agency. If the results of that study indicate that the process can be made sufficiently safe, the League supports strong regulation accompanied by strict enforcement and intensive oversight. In addition, the League believes that careful planning concerning the pace and extent of the drilling must be done, since this is a highly industrial process that will occur in predominantly rural areas. This planning should include an analysis of any impact the extraction activity will have on the current local economy, especially the growing agricultural and tourism businesses in the areas over the shale.
